The scholarships are awarded annually to local educators to develop their skills and assist them as they strive for excellence. Teachers can turn continuing education into classroom results.

These scholarships are named for the late Barbara Deverick and Gwyn B.

Price, former Blue Ridge Electric Membership Corporation leaders and champions of education. Mr. Gwyn B. Price of Ashe County helped organize electric and telephone cooperatives and was a founding director of Blue Ridge Electric. He was head of the NC Rural Electric Authority for 31 years and was an educator/principal for 28 years. Barbara H. Deverick of Caldwell County was equally devoted to her community, serving on the Board of Directors for Caldwell Community College, chairing the Caldwell County School Board or giving her time to non-profit causes.

Teachers may apply for financial assistance to obtain renewal credits, to complete certifications or to participate in specialized workshops and training programs, including training related to the use of instructional technology in the classroom.

Teachers who are currently employed by and teaching in Watauga County Schools and who plan to teach in the system in 2012-2013 are eligible to apply. Scholarship funds may be used to pay for registration, materials fees and out of town travel for classes or workshops completed between March 1, 2012 and May 31, 2013.

Approximately \$4,000 will be awarded this year. Applicants are invited to complete the application and mail it along with the requested documentation to the Watauga Education Foundation, P.O. Box 2658, Boone, NC 28607, no later than February 15, 2012. Applications may also be obtained from any principal of Watauga County Schools or by contacting the Foundation's office at 268-1273 or via email at info@wataugaeducationfoundation.org.

Applications received after February 15, 2012 will not be considered. The Foundation and BREMCO intend to announce scholarship winners no later than March 1, 2012
